CHINA CUSTOMS ADVANCE MANIFEST
(CCAM)

Dear Valued Customers,

Herewith we would like to inform you concerning progress of China Customs Advance Manifest implementation.

As per recent updates, CCAM regulation will be fully implemented in SHANGHAI port (CNSHA) on 28th June 2014 (date of arrival vessels in Shanghai - as POD or T/S port).

Customs will require submission of EDI declaration 24 hours prior loading of the cargo in POL or PTS against the voyage entering in Chinese waters.

Thanks to note that there will be no grace period, thus we will comply with the rules in order to avoid blocking of cargo at destination and customs fines.

Filing Time Frame:

- CCAM Filing (original declaration) is 36 hours before vessel departure from POL (direct shipment) or PTS (if transshipment)
- SI cut off to be received by Shanghai team is between 72-36 before vessel arrival.
- Therefore our cut off for FINAL SI received from shipper is 24 hours before vessel departure from POL.

Please attention:

- For other Chinese ports current rule remain unchanged and CCAM filing must be done at the latest 72 hours prior vessel arrival in China.
- SOC Tank
 - Local discharge in shanghai: must be declared as Empty(nature and weight of the residue to be inserted in the body of the bill
 - Transshipment in Shanghai: must be declared as Full (weight of residue must be inserted in gross weight cargo field.)
- Hazardous cargo: hazardous container and not hazardous container cannot be mixed on one bill. However if 1 container include a mix of Hazardous and non-Hazardous cargo it is allowed to issue 1 single B/L .

Amendments:

Amendment process is very strict, and requires full compliance with below guidelines:

- Amendments after original declaration **MUST be approved by Shanghai** office and will need a manual declaration to Customs.
- **Only 1 (one) amendment** per B/L after original declaration will be allowed (but this amendment can include modification on several items), all further amendment's requests will be rejected.
- COD: before proceeding with any COD request approval from Shanghai office must be received
- Split or Merge bill of lading after original declaration has been sent is not allowed.
